

Case study: Workplace Planner

Real-estate costs are the second-biggest burden on businesses after wages. As a result of pressure to reduce these costs, a large investment bank moved a sizeable section of its staff to a new building with fewer desks than people. The plan was to target a desk-share ratio of up to 1:5, prompting concerns that teams would find it difficult to allocate desks accordingly.

The bank called upon Brickendon to design, build and implement a workforce planning tool that effectively monitored desk allocation versus desk demand, with the aim of avoiding the potential chaos and inefficiency that might have otherwise ensued.
